**Entry Information:** These rules apply to candidates for Region and District Lion of the Year. Each club in District 4-C5 may nominate one Lion for the District Lion of the Year competition. This individual need not be Club Lion of the Year.

**Nomination:** Submission must include summarized score sheet and a one-page (Times New Roman,

size 12 font) essay that highlights how you exemplify Lionism in your life. The nomination must be in the hands of the Cabinet Secretary by March 15, 2024 to be

considered.

**Essay:** Essay is a summary of Lionism in your life for the Contest period only. Reference to the

activities on the scoresheet is important.

**Point System:** Judging will be based on a point system outlined on the form. Scoring by the Club President

and the Board of Directors must be attested.

**Judging:** The points scored and the description in the essay will be used with equal weight as

bases of judgment. The panel of judges will be appointed by the District Governor. The final selection of the Lion of the Year will be chosen by the District Governor, taking into account the recommendations of the judges panel. There will be a Lion of the Year selected for each Region. One individual will be named the District Lion of the Year.

Award presentation will be made at the District Convention.

The District Governor, Vice District Governors and their families are not eligible for this award. Once a Lion has received the award, the Lion is no longer eligible to receive it again.
